

The regular meeting of the City Council was held in the Municipal Court Room on July 2, 1974 at 7:30 P.M. with Mayor Fulks presiding.

On motion by Jim Humphreys, seconded by Roy Roberts and carried by unanimous vote minutes of the previous meeting were approved as corrected.

Mr. Bill McGannon of Oak Avenue appeared before Council asking for relief on the parking situation on Oak Avenue. Council discussed this matter with Mr. McGannon and requested the Attorney to look into the matter as to what is being done in similar situations in other cities. Mr. McGannon stated that if the City did not do something about the situation he was going to make himself a stand and put it out in front of his house while he is away and hopes to see if there when he comes back. 6599

On motion by Roy Roberts, seconded by W. F. McElroy and carried by unanimous vote Council moved that S. E. Trinkle be recommended to Judge of Circuit Court for reappointment to Zoning Board of Appeals for five (5) year term effective June 2, 1974. 6602

Mr. Franks discussed briefly Project on Guest River Road (Route 620). Council instructed City Manager to prepare resolution and bring back to Council. 6603

On motion by Jim Humphreys, seconded by Roy Roberts the following Resolution in recognition of Robert Leonard was passed. Page 118 6604

On motion by W. F. McElroy, seconded by George Hunnicutt and carried by unanimous vote Council moved that the next regular scheduled Council meeting be moved from July 16 to July 23. 6605

Councilman Hunnicutt discussed with Council liability of the City of Norton with reference to Norton Redevelopment and Housing and Industrial Development Authority and other entities of the City. City Attorney was instructed to look into this matter and report back to Council. 6606
