

The regular meeting of the City Council was held in the Municipal Court Room on October 17, 1972 with Vice Mayor Fultz presiding.

The City Manager announced that the make-up council meeting scheduled for October 10th was not held due to lack of quorum.

Dr. Joana Maiden, Acting Director Wise County Health Department and Mr. D.B. Holyfield, Administrative Assistant of Wise County Health Department appeared before council and presented proposed resolution regarding change in districting of Health Department. The proposed redistricts to comply with an executive order of the State Governor requiring that State Health Department Districts conform to planning district boundaries.

On motion by Jim Humphreys, seconded by W.F. McElroy and carried by unanimous vote council moved that Mr. Wright Dawson be reappointed to City of Norton Welfare Board for a four year term, said term to expire Nov. 21, 1976.

On motion by Robert Leonard, seconded by Jim Humphreys and carried by unanimous vote Council moved that Robert (Bud) Barton was appointed as member of Housing, Electrical and Plumbing Appeals Board to fill the unexpired term of Ron Hamlin, resigned, said term to expire Sept. 18, 1974.

Vice Mayor Fultz inquired if there was anything further on Retirement Fund. Mr. Franks stated that there was no new development to report on.

On motion by Robert Leonard, seconded by W.F. McElroy and carried by unanimous vote council moved that next regular council meeting would be held on Nov. 6th instead of regular date of Nov. 7th due to election.

Mr. Franks advised council for their information that bids had been received on new garbage truck with Super Service Garage submitting low bid of \$7,373. The other bid submitted by Witt Moto Company with a price of \$7,869.
