

The regular meeting of the City Council was held in the Municipal Court Room on September 7, 1971 at 7:30 P.M. with Mayor Flanary presiding.

Present: V.O. Flanary, Robert Leonard, Ike Fultz, C.W. Bryant

Absent: Archie Woods

Minutes of the previous meeting were read and approved.

Mayor Flanary discussed with council the Bear Creek property. He advised Council of the reasons the Manager had to be in Richmond regarding Bear Creek proposed development.

On motion by Ike Fultz, seconded by Robert Leonard and carried by unanimous roll call vote council moved the adoption of the following resolution:

Be It Resolved by the City Council of the City of Norton, Virginia, that Don R. Pippi be, and he hereby is employed by said Council for an indeterminate time to serve as City Attorney for the City of Norton, and he shall perform such duties as are prescribed by the Code of City of Norton. He shall be remunerated as follows: 5788
One Hundred sixty dollars (\$160) monthly for prosecution in City Court, and two hundred forty dollars (240) monthly for other services as prescribed by Code, and other services performed shall be arranged by negotiation prior to rendering of such other services.

On motion by Robert Leonard, seconded by Ike Fultz and carried by unanimous vote council moved that the Bear Creek Property as described in the attached deed and map be rezoned from A Residential to B Residential. (Page 58)

On motion by Robert Leonard, seconded by C.W. Bryant and carried by unanimous roll call vote council moved that the Architectural Fee to Charles McElroy in amount of \$5,841.37, first payment for Neighborhood Facilities Project be paid in accordance with contract, said fund to be charged to Capital Reserve.

Councilman Fultz advised council that as an appointed member of the Highway Safety Commission for City of Norton he would like to point out a few things he considered unsafe and his recommendation for such.

1. Bridge he had discussed in Ramsey on Rose Avenue - there had been a wreck on bridge Saturday damaging car.
2. He had recommended that two meters in section of swimming pool be removed so that it would enable motorist to see children crossing from pool. He stated there had been a child hurt in the past.
3. He recommended that light on viaduct and one at Park Avenue & 11th Street be changed to Stop & Go.

On motion by Ike Fultz, seconded by C.W. Bryant and carried by following votes, council moved that City Manager see what can be done to change two lights to Stop & Go, one at Viaduct and one on Park Avenue & 11th. Fultz, Leonard, Bryant, Yes; Flanary - No.




