BE IT ORDAINED by the Council of the City of Norton, Virginia, that:

Part III. THE BUILDING CODES, CHAPTER 1, THE BUILDING CODE, SECTION 1. ADOPTION OF BUILDING CODE, BE AMENDED AS FOLLOWS:

There is hereby adopted by the City of Norton for the purpose of establishing rules and regulations of the construction, alteration, removal, demolition, equipment, use and occupancy, location and maintenance of buildings and structures, including permits and penalties, that certain building code, known as the National Building Code, recommended by the American Incurrence Association, successor to the National Board of Fire Underwriters, being particularly the 1967 Edition thereof, and inafter deleted, modified or amended, of which not less that three (3copies) have been and now are filed in the office of the Clerk of the City of Norton and the same are hereby adopted

and incorporated as fully as if set out at length herein, and from the date on which this ordinance shall take effect, the provisions thereof shall be controlling in the construction of all buildings and other structures within the corporate limits of the City of Norton.

BE LIT ORDAINED by the Council of the City of Norton, Virginia, that:

PART III. THE BUILDING CODES, CHAPTER II, ELECTRICAL CODE OF the CITY OF NORTON, VIRGINIA, SUB_SECTION V, BE AMENDED AS FOLLOWS:

(5) the 1968 issue of the National Electrical Code is hereby adopted and approved as a part of this ordinance as a minimum standard.

BE IT ORDAINED by the Council of the City of Norton, Virginia, that:

PART III. THE BUILDING CODES, CHAPTER III, PLUMBING CODE OF THE CITY OF NORTON, VIRGINIA, ARTICLE IV. SOIL AND WASTE PIPES, BE AMENDED AS FOLLOWS:

SECTION 40, MATERIAL OF PIPING ABOVE GROUND WITHIN BUILDINGS.

Soil, Waste and vent piping above ground within a building shall be of cast iron, galvanized wrought iron, galvanized steel, lead, brass or copper pipe, or material approved in the National Building Code, recommended by the American Insurance Association, successor to the National Board of Fire Underwriters, more specifically the 1967 Edition.

SECTION 41. MATERIAL AND SIZE OF UNDERGROUND PIPING WITHIN BUILDINGS.

Building drains, when underground, shall be of cast iron, soil pipe of not less than 4 inches internal diameter, all other soil, waste and vent pipes shall be cast iron soil pipe of the size required, or materials approved in the National Building Code recommended by the American Insurance Association, successor to the National Board of Fire Underwriters, 1967 Edition.

BE IT ORDAINED by the Council of the City of Norton, Virginia, that:

PART II, CHAPTER IV, FIRE PREVENTION OF THE CITY OF NORTON CODE, SECTION IV-1, FIRE PREVENTION CODE, BE AMENDED AS FOLLOWS:

The provisions of the Fire Prevention Code recommended by the American Insurance Association successor to the National Board of Fire Underwriters, 1965 Edition, with the October, 1966, revised supplement edition, is hereby adopted and made a part of this Code as fully as though each section, sentence, clause or phrase were set out kerein; provided, that the rules and regulations of the said fire prevention code are not in conflict with

the Taws of the State or the ordinances of the City, It shall be unlawful for any person to fail to comply with the rules and regulations hereby adopted. A reasonable number of copies of said fire prevention code shall be kept in the office of the City Manager, and may be obtained from said office between the hours of 9:00 A.M., and 5:00 P.M., of each weekday, excluding Saturday.

BE IT ORDAINED by the Council of the City of Norton, Virginia, that:
