

July 11, 1967

The regular meeting of the City Council was held in the Municipal Court Room on July 11, 1967 at 7:30 P.M. with Mayor Flanary presiding.

Present: V.O. Flanary, G.E. Hunnicutt, C.W. Bryant, R.L. Collins

Also Present: David Norman, City Manager & Leslie Mullins & Robert Stump, Attorneys

Absent: S.H. Neeley, Jr.

Minutes of the previous meeting were read and approved.

Mr. Norman & Councilman Hunnicutt advised Council of status of insurance policy. #4077

A group of citizens from Poplar Street with C.D. Hunt and D.H. Goodman as spokesmen, appeared before Council requesting that something be done to the street. After a discussion of this matter, Council assured these citizens that this matter will be looked into. #4078

Mr. C.D. Hensly of Ridge Avenue appeared before Council requesting street light for pole near his residence on Ridge Avenue. Matter referred to City Manager. #4079

Council agreed to continue tour of streets immediately after Council meeting. #4080

Mr. Norman presented to Council recommendation of Greater Norton, Inc. for holidays to be observed with reference to meters. #4081

On motion by G.E. Hunnicutt, seconded by C.W. Bryant and carried by unanimous vote, Council moved that the following holidays be observed in reference to parking meters: Christmas, New Years, Memorial Day, July 4th, Labor Day, Thanksgiving

Mr. Norman discussed with Council the pool and playground property, with reference to Park Avenue and relocation. After a lengthy discussion and on motion by G.E. Hunnicutt, seconded by R.L. Collins and carried by unanimous vote, Council moved: #4082

1. Call on Planning Commission to come up with at least three good places for substantial playground located in different parts of City.
2. That members of the Rescue Squad be requested to appear before Council to discuss relocation of their proposed building site.
3. Empower City Manager, with assistance of City Attorney, to open up negotiations with N & W Railway Company regarding land on Park Avenue.

The City Manager advised Council of ordinance regarding sidewalks. He also advised he will proceed with plans for extension of sidewalk on Chestnut Street. #4083

Mr. Norman advised Council of City's financial status at end of fiscal year June 30, 1967. #4084

Mr. Norman advised Council of car tag enforcement. #4085

Sharing of cost of Circuit Court facilities was postponed until next meeting. #4086


Mayor Flanary presented request of Bill Necessary regarding road on East Park Avenue. Matter referred to City Manager. #4087


Council discussed briefly damage done at cemetery lot. Mr. Norman advised Council that gate had already been installed. #4088
