

November 21, 1967

The regular meeting of the City Council was held in the Municipal Court Room on November 21, 1967 at 7:30 P.M. with Mayor Flanary presiding.

Present: V.O. Flanary, C.W. Bryant, R.L. Collins, S.H. Neeley, Jr.

Absent: G.E. Hunnicutt

Also Present: David B. Norman, City Manager and Robert Stump and Leslie Mullins, Attorneys.

Minutes of the previous meeting were read and approved.

Mr. Woody Conner appeared before Council, in behalf of his mother, Mrs. A.C. Conner, inquiring as to status of previous request regarding heavy equipment being parked on residential property. After lengthy discussion, matter referred to Building Inspector.

Council discussed City Manager's Report.

On motion by S.H. Neeley, seconded by C.W. Bryant and carried by unanimous vote, Council moved that sewer line on Roberts Ave., S.W. to the Leho property be left as is, and that the sewer connection fee not be refunded to said party, as per recommendation of City Manager.

Council discussed storm drain of 10th St., N.W.

Mr. Robert Leonard appeared before Council, as per request of Lenowisco, and presented audits of Lenowisco.

Mr. Norman read letter from Va. State Police Dept. stating that they will be willing to relocate the Norton Office Building as per list of specifications.

Council discussed comprehensive health survey.

#4227

On motion by S.H. Neeley, seconded by R.L. Collins and carried by unanimous vote, Council moved that the following resolution regarding comprehensive health survey be passed:

BE IT RESOLVED by the City Council of the City of Norton, Virginia that it hereby requests the Virginia Department of Health to undertake a comprehensive health survey of the City of Norton. Such survey to evaluate the health, sanitation and housing facilities within the corporate limits of the City of Norton and areas immediately adjacent thereto. The City of Norton further requests that the Virginia Department of Health make recommendations to the City for action to be taken to correct any conditions which are found to exist as a result of the survey.

Council instructed City Manager to advise City Auditor that Council is very concerned in having audit finished and is requesting the Welfare Report to be presented at next Council meeting.

Council discussed status of paving.

#4229

City Manager presented bids received on garbage body. Tidy Corp. - \$5,595; Baker Equipment Co. - \$5,781; Cary Hall Mchy. - \$5,050, less 1%.


Mr. Beech with Cary Hall Mchy. appeared before Council to demonstrate a garbage truck. After a lengthy discussion, and on motion by S.H. Neeley, seconded by C.W. Bryant and carried by unanimous roll call vote, Council moved that purchase of said demonstratic garbage truck be made, provided that approval by Mayor Flanary, Councilman Collins and City Manager is given after garbage run; price of said truck to be \$8,100, plus \$600 for hoist installed.

On motion by C.W. Bryant, seconded by R.L. Collins and carried by unanimous vote, Council moved that Mrs. J.C. Holcomb be recommended to the Judge of the Circuit Court for appointment to City of Norton Welfare Board for a term of three years, said term to expire November 21, 1970.


On motion by S.H. Neeley, seconded by C.W. Bryant and carried #4232
