

February 5, 1963

The regular meeting of the City Council was held in the Municipal Court Room on February 5, 1963 at 7:00 P.M. with Councilman J.C. Holcomb presiding.

Present: J.C. Holcomb, Archie Woods, J.B. Taggart

Minutes of the previous meeting were read and approved.

On motion by J.B. Taggart, seconded by Archie Woods and carried by unanimous vote, council granted permission for the issuance of an on-off premise beer license to Arlene Craiger, T/ A White Front Cafe, 518 Park Ave. #2329

On motion by J.B. Taggart, seconded by Archie Woods and carried by unanimous vote, council moved that renewal of taxi driver's permits be granted the following persons: Paul Stidham, Carson Ward, William P. Martin, Kinerd Ison, Efford Laney, Dallas Hinkle, W.C. Marshall, N.W. Stallard, Odell Greear, John Lovell, B.B. Collier, J.C. Johnston. #2330

On motion by J.B. Taggart, seconded by Archie Woods and carried by unanimous vote, council granted permission to George Perry for renewal of his taxicab driver's permit.

On motion by J.B. Taggart, seconded by Archie Woods and carried by unanimous vote, council granted permission to Bob Coffey for renewal of his taxi driver's permit.

On motion by Archie Woods, Seconded by J.B. Taggart and carried by unanimous vote, council granted permission to Herbert Kirk for renewal of his taxi driver's permit.

On motion by J.B. Taggart, seconded by Archie Woods and carried by unanimous vote, council granted permission to Terry Sexton for renewal of his taxi driver's permit.

On motion by J.B. Taggart, seconded by Archie Woods and carried by unanimous vote, council granted permission to Ed Wheatley for renewal of his taxi driver's permit.

The applications of Elmer I. Heaberlin and Gene P. Carter for renewal of their taxi drivers' permits were presented to council for their approval. #2331
After consideration of this matter, council instructed Mr. Jester, the City Manager, to advise the above mentioned men that they were now operating on an invalid permit and if they desire to do so, council would be glad for them to explain their case to them.

Mr. George Hunnicutt appeared before council and asked permission to unload another car load of coal at the dock now operated by Bill Kline, which is located on the City's right of way. #2332

On motion by Archie Woods, seconded by J.B. Taggart and carried by unanimous vote, council moved that Mr. George Hunnicutt be granted permission to unload another car load of coal at the above dock and that the City Manager be instructed to work out an equitable agreement with Mr. Bill Kline regarding permission for unloading at this dock in order to eliminate persons having to appear before council each time for permission to unload; and also that such an agreement should net the City a minimum revenue of \$10.00 per car load at the site.


Mr. Jester presented request of Mrs. Fred Adams of the Josephine #2333 Area regarding water connection to her property. Council referred this matter to the City Manager.

Mr. Jester read to council a report of the Norton Volunteer Fire Department for the year 1962. Mr. Jester was commended by council on this informative report. #2334


Mr. Taggart brought to council's attention the urgency of getting the supplementary application for West Norton Sewage Plant in progress. After discussion of this matter, council instructed the City Manager to expedite this matter Wednesday morning, February 6th. They further suggested that Mr. Lindsey, engineer for sewage treatment plant, be contacted by telephone, said information needed for application to be received by telephone from Mr. Lindsey of the firm Hayes, Seay, Mattern & Mattern. #2335

Mr. Winston brought to council's attention that there was some question regarding the ordinance concerning the Referendum for the bond issue. After council discussed this matter with Mr. Winston, they instructed Mr. Jester and Mr. Winston to get in contact with Mr. Sult and arrange a meeting with Mr. Strader who would be in the City, Thursday, February 7th. #2336

There being no further business to come before the council same adjourned.
