

An organizational meeting of the Norton City Council was held in the Council Chambers on Tuesday, July 5, 1994 at 7:00 p.m. with City Manager E. W. Ward presiding.

Present: Roy Roberts, Jack Wallace, William Mays, Ron McCall, and Robert Raines

Also Present: E. W. Ward, City Manager

Mr. Ward opened the floor for nominations of Mayor.

William Mays nominated Mr. Robert Raines. Upon a motion by Ron McCall, seconded by Roy Roberts, and passed by unanimous vote, Council moved that the nominations cease. Mr. Ward declared Mr. Robert Raines was re-elected Mayor. Mr. Raines came forward, was sworn in by the Clerk, took his seat on Council, and began presiding over the meeting.

Mayor Raines opened the floor for nominations as Vice Mayor.

Roy Roberts nominated Mr. William Mays. Upon a motion by Jack Wallace, seconded by Ron McCall, and passed by unanimous vote, Council moved that the nominations cease. Mayor Raines declared Mr. William Mays re-elected as Vice Mayor. Mr. Mays came forward, was sworn in by the Clerk, and took his seat on Council

At this time, Mr. Roberts, Mr. Wallace, and Mr. McCall took their seats on Council.

Mayor Raines opened the floor for nominations of City Manager.

Roy Roberts nominated Mr. E. W. Ward.

Upon a motion by Jack Wallace, seconded by William Mays, and passed by unanimous vote, Council moved that the nominations cease.

Mayor Raines declared Mr. E. W. Ward reappointed as City Manager and advised Mr. Ward that Council does appreciate the fine job he is doing.

Mayor Raines opened the floor for nominations of City Clerk.

Ron McCall nominated Mrs. Mary Brown.

Upon a motion by William Mays, seconded by Roy Roberts, and passed by unanimous vote, Council moved that the nominations cease.

Mayor Raines declared Mrs. Mary Brown reappointed as City Clerk.

Mayor Raines opened the floor for nominations of City Attorney.

Jack Wallace nominated Mr. Joe Pippin. Upon a motion by Ron McCall, seconded by Roy Roberts, and passed by unanimous vote, Council moved that the nominations cease.

Mayor Raines declared Mr. Joe Pippin reappointed as City Attorney.

A discussion was held on the dates and times of Council meetings. Upon a motion by William Mays, seconded by Roy Roberts, and passed by unanimous vote, Council moved to keep the same schedule of meetings: each first and third Tuesday of the month at 7:30 p.m.

Mayor Raines asked if the order of voting needed to be voted on at this time and was advised if there were to be any changes, now is the time to do so. It was the consensus to leave the voting order as is with the Mayor voting last.


