

The regular meeting of the City Council was held in the Council Chambers on March 3, 1987 at 7:30 P.M. with Mayor Daniels presiding.

Present: Roy Roberts, Robert Raines, Cliff Daniels, Milas Franks, William Mays

Also Present: C.R. Brown, City Manager

The Invocation was given by Rev. Robert Rhinehart, followed with Pledge of Allegiance led by T.D. Lassiter. 13744

On motion by Milas Franks, seconded by William Mays and carried by unanimous vote, Council moved that minutes of February 3, 1987 be approved as presented. 13745

On motion by Milas Franks, seconded by Robert Raines and carried by unanimous vote, Council moved that minutes of February 17, 1987 be approved as presented. 13746

The Mayor called for audience for visitors.

Mr. T.D. Lassiten of 223 Locust Avenue, (Southside) representing a group of citizens from the Southside of the City appeared before council and addressed the subject of some kind of protection for the people in that area. This matter was brought about by the recent snatching of pocket-book from Sadie Coleman as she returned home from work. He stated they would like this situation corrected with some type of assurance. He also inquired as to a curfew law in the City. He also expressed need for street lights and trimming of bushy trees in order to eliminate hiding places. Mr. Brown advised the street lights were on order and would be installed as soon as they were in. He also advised he was not sure about the curfew laws but would look it up in code and talk with Chief Mongle about it. Mayor Daniels ask that all the people over there be more aware of noises and help out in these situations if they occur again. Mr. Lassiter expressed his appreciation for help Police Department had given this section. 13747

On motion by Robert Raines, seconded by William Mays and carried by unanimous roll call vote, Council moved that "An Ordinance Amending and Reenacting Sections 22-1, 22-13, 22-15 and 22-18 of the Zoning Ordinance of the City of Norton, Virginia to provide for the Establishment of Regulations for Land Subject to Flooding" be passed on second reading. On motion by Milas Franks, seconded by Robert Raines and carried by unanimous roll call vote, Council moved that "An Ordinance of the City Council of the City of Norton, Virginia Amending and Reenacting Section 2-1 Section 19 and Section 2-4 Section 19-7 of the Subdivision Ordinance of the City of Norton, Virginia Amendments adopted on May 17, 1983 to Provide for the Establishment of Regulations of Land Subject to Flooding" be passed on second reading. (Insert) 13749

Discussion of Proposal for the City of Norton General Reassessment in 1987. Mr. Brown addressed this subject, advising Mr. Marcum had received proposal for this reassessment from Mr. Frank Stacy. He advised he would like to bring this back at April 7th meeting and request transfer of funds to cover this reassessment. This matter is for information only. 13750

On motion by Roy Roberts, seconded by Milas Franks and carried by unanimous vote, Council moved they go into executive session to discuss personnel as Per 2.1-344 (A) (1) of the Code of Virginia, As Amended. 13751

On motion by Roy Roberts, seconded by Milas Franks and carried by unanimous vote, Council moved they go back into regular session.

The Mayor declared Council back in regular session.

Robert Raines nominated Bill Stokes for appointment to the Lebanon Group Home Board of Directors for a four year term, said term to expire 4-1-91.

On motion by Milas Franks, seconded by William Mays, Council moved that nominations be closed.

The Mayor declared Bill Stokes appointed to the Lebanon Group Home Board of Directors for a four year term, said term to expire 4-1-91. 13752

The Mayor advised they did have some discussion concerning Mr. Frank's Successor. Will be on Agenda at next council meeting.

Comments by the City Manager - No comments unless you would like to bring before council legislation which is in the making.

Mayor Daniels presented the particular legislation which city is effected by,

1. Annexation moratorium which would be retroactive to Jan. 1, 1987. 13753
2. School Board Appointments - Would modify manner in which they are made. No Appointment can be made unless name brought up at advertised public hearing.
3. Conflict provision that stopped members of council from voting on School Board Budgets and appropriations who had members of their family working for School Board.

All three of those have direct implication on us as we operated.

Comments by Council - Mayor Daniels advised council of Antique Car Exhibition to be held in Norton, possibly in August. This is sponsored by the Rescue Squad. He advised he would like council to go on record as very supportive of that idea. He also ask that Mr. Brown's office offer assistance in this matter. Councilman Mays advised Bruce Rose was the "Daddy" of this show. 13754
