

The regular meeting of the City Council was held in the Municipal Council Chambers on August 18, 1987 at 7:30 P.M. with Mayor Daniels presiding.

Invocation was given by Vice Mayor Raines, followed with Pledge of Allegiance led by Rev. Don Bowles. 13905

On motion by Jack Wallace, seconded by Robert Raines and carried by unanimous vote, Council moved that minutes of August 4, 1987 be approved as presented with correction in paragraph 13894 to read "Boco Ltd. & Wharton, Inc., across from the Holiday Inn." 13906

Ruth Mundy of 1222 Chapman Street appeared before council requesting an adjustment on her water bill, said water bill in amount of \$112.01. She advised she had had an inside leak. Mr. Brown advised council he had talked with Mrs. Mundy and had advised he would set up a payment plan for this bill but in line with City Policy could not make an adjustment on the bill. After a brief discussion council agreed to leave this matter for Mr. Brown to work out according to City Policy. 13907


2. Employee picnic, August 28th at Flag Rock with Games, etc. beginning at 4:30 with dinner at 6:00 P.M.
