

The regular meeting of the City Council was held in the Municipal Court Room on March 18, 1986 at 7:30 P.M. with Mayor Hunnicutt presiding.

Present: Roy Roberts, Robert Raines, George Hunnicutt, Milas Franks, Cliff Daniels

Also Present: C.R. Brown, City Manager & Kenneth Asbury, Attorney

On motion by Cliff Daniels, seconded by Robert Raines and carried by unanimous vote, Council moved that minutes of February 18, 1986 be approved as presented. 13407

On motion by Roy Roberts, seconded by Milas Franks and carried by unanimous vote, Council moved that minutes of March 4, 1986 be approved as presented. 13408

Mayor Hunnicutt recognized Mr. James Robinson, State Representative and advised council of his desire to discuss a legal matter with them. He preferred going into executive session. 13409

On motion by Cliff Daniels, seconded by Roy Roberts and carried by unanimous vote, Council moved they go into executive session to discuss legal matters as Per 2.1-344 (A) (6) of the Code of Virginia, as Amended. 13410

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved they go back into regular session. 13411

The Mayor declared council back in regular session and advised that they had discussed matters of pending litigation and will just have to wait until it comes out in the wash. Expressed appreciation to Mr. Robinson for his help. 13412

Confirmation of understanding between Norton City Council and the Norton School Board as pertains to Capital Improvement Projects and Funding.

Council discussed this matter at length, with Mr. Armentrout addressing the subject. Council brought out the matter that after the Literary fund monies are spent, they will consider appropriating \$70,000 to \$80,000 from local funds each year for the next three years to apply to projects if funds are available. 13413


