

The regular meeting of the City Council was held on June 3, 1986 in the Municipal Court Room at 7:30 P.M. with Mayor Hunnicutt presiding.

Present: Roy Roberts, Robert Raines, George Hunnicutt, Milas Franks, Cliff Daniels

Also Present: Ernie Ward, Asst. City Manager & Kenneth Asbury, Attorney

Invocation was given by Rev. Claude Quillen.

On motion by Robert Raines, seconded by Roy Roberts and carried by unanimous vote, Council moved that minutes of May 20, 1986 be approved as presented. 13470

The Mayor called for visitors from audience who were not listed on the agenda. Mr. William Rosenfeld spoke to council on subject of KKK parade scheduled to be held in Norton June 7th. He voiced his objection mainly as a protection for the youth. He stated he hoped everyone would stay home on that day. Council ask that Mr. Asbury, the City Attorney, address this matter. Mr. Asbury stated this parade could not be denied due to Constitutional rights. He also advised that Chief Mongle, City Manager & himself were preparing the permit which would be finalized by Friday. He also expressed a concern for the youth and hoped that as many people as possible stay home at that time. 13471

Public Hearing on "An Ordinance Adopting the Budget for the City of Norton, Virginia for the Fiscal Year of July 1, 1986 thru June 30, 1987, Appropriating Funds for all Contemplated Expenses of the Municipality for the Fiscal Year and Placing levies Upon All Real Estate, Personal Property, Bank Stock, Licenses, Automobile Licenses, Water and Sewer Rates and Revenue Sharing." 13472

Ernie Ward, the Asst. City Manager, highlighted the Budget in its entirety. There being no visitors present to discuss the budget, Council briefly discussed the budget. The City Attorney advised no action needed to be taken on the budget at this time.

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous roll call vote, Council moved that "A Resolution Absolving the Water & Sewer Fund of an account payable to the General Fund, in amount of \$90,136.41 be passed and the City Manager be authorized to do whatever paper work the auditor requires. On motion by Milas Franks, seconded by Robert Raines and carried by unanimous vote, Council moved they go into executive session to discuss personnel as Per 2.1-344
