

The regular meeting of the City Council was held in the Municipal Court Room on June 18, 1985 at 7:30 P.M. with Mayor Hunnicutt presiding.

On motion by Milas Franks, seconded by Ray Salyers and carried by unanimous vote, Council moved that minutes of June 4, 1985 be approved as presented, 13213

Public Hearing on "An Ordinance Amending the 1984-85 Budget of the City of Norton by Appropriating \$170,000.00 from the City's General Fund Balance to the City of Norton School Board."

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous roll call vote the Ordinance "Amending the 1984-85 Budget of the City of Norton by Appropriating \$170,000 from the City's General Fund Balance to the City of Norton School Board was passed. 13214

An Ordinance adopting the Motor Vehicle Code as Amended and the Code of Virginia as Amended on Driving a Motor Vehicle While Intoxicated."

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved they go into executive session to discuss personnel as Per 2.1-344 (A) (1) of the Code of Virginia, as Amended, and Legal Matters as Per 2.1-344 (A) (6) of the Code of Virginia, As Amended. 13218

On motion by Cliff Daniels, seconded by Ray Salyers and carried by unanimous vote, Council moved they go back into regular session.

The Mayor declared council back in regular session. 13219

On motion by Ray Salyers, Eddie Lovell was nominated for appointment to the Norton Redevelopment & Housing Authority for unexpired term of Bruce Fraley, said term to expire Jan. 28, 1986.

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved that nominations be closed. 13220

The Mayor declared Eddie Lovell appointed to Norton Redevelopment & Housing Authority to fill unexpired term of Bruce Fraley, said term to expire Jan. 28, 1986.

Milas Franks moved that Jon Rockett be recommended to the Judge of the Circuit Court for appointment to City of Norton Board of Zoning Appeals for 5 Year term, On motion by Cliff Daniels, seconded by Ray Salyers and carried by unanimous vote, Council moved that nominations be closed. 13221

The Mayor declared Jon Rockett recommended to Judge of Circuit Court for appointment to City of Norton Board of Zoning Appeals, said term to expire June 2, 1990.

Cliff Daniels nominated Dorothy Chittester to Norton Industrial Development Authority to fill the unexpired term of Bill Clements,

Milas Franks moved, seconded by Cliff Daniels and carried by unanimous vote, Council moved that nominations be closed. 13222

The Mayor declared Dorothy Chittester appointed to the Norton Industrial Development Authority to fill the unexpired term of Bill Clements, said term to expire May 10, 1987.


The Mayor ask that it be noted that he neither nominated nor voted with reference to this appointment.

The Mayor advised that council wished to carry over the other two appointments. 13223


No report from City Manager - turned over to Cliff Daniels for report.
