

The regular meeting of the City Council was held in the Municipal Court Room on November 6, 1985 at 7:30 P.M. with Mayor Hunnicutt presiding.

On motion by Milas Franks, seconded by Cliff Daniels and carried by unanimous vote, Council moved that minutes of October 15, 1985 be approved as presented.

On motion by Robert Raines, seconded by Cliff Daniels and carried by unanimous vote, Council moved that minutes of October 29th be approved as presented. 13307

No visitors present to bring matters before the council. 13308

The Mayor announced it was time for public hearing on "A Resolution of Council Adopting a new Grievance Procedure for both Municipal Employees and the Police Department and Revoking all Prior Grievance Procedures."

Mr. Asbury, the City Attorney, addressed this grievance procedure. Council briefly discussed this matter.

On motion by Milas Franks, seconded by Cliff Daniels and carried by unanimous vote, Council moved that "Resolution of Council Adopting a New Grievance Procedure for both Municipal Employees and the Police Department and Revoking All Prior Grievance Procedures" be passed. 13309

Public Hearing on consideration of adopting a new base Map for the City of Norton.

The City Manager discussed this Base Map with the audience and Council.

Linda Sturgill of West Main Avenue addressed Council on subject of 16th Street. Council discussed this matter with Ms. Sturgill.

After a brief discussion, the City Manager was instructed to bring this map change back at next council meeting for second adoption. 13310

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved that "An Ordinance of the City Council of the City of Norton, Virginia, held on November 6, 1985 adopting the Official Base Map for the City of Norton, Virginia, be passed on first reading.

A proposed Amendment to the Zoning Ordinance of the City of Norton was Recommended to include conditional Zoning as Per 15.1-491.1 of the Code of Virginia, as amended.

Council briefly discussed this matter.

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved that a proposed Amendment to the Zoning Ordinance of the City of Norton, to include Conditional Zoning, as Per 15.1-491.1 of the Code of Virginia, as Amended be tabled indefinitely. 13311

Vice Mayor Daniels addressed the subject of the Year 2000. He stated he would like to see the City advertise for professional services in area of Planning and Redevelopment of a retainer type.

Discussion of status of City Code. He would like both of these subjects placed on Agenda for next council meeting. 13314


