

The regular meeting of the City Council was held in the Municipal Court Room on March 6, 1984 at 7:30 P.M. with Mayor Hunnicutt presiding.

Invocation by Rev. L.K. Beavers

On motion by W.F. McElroy, seconded by Vic Jones and carried by unanimous vote, Council moved that minutes of February 21, 1984 meeting be approved as presented. 11148

Discussion of Water Reserves - Mr. Brown advised council that on March 1st both reservoirs were full and overflowing. Council discussed this matter with Mr. Brown and directed that he have his peoples come up with a plan, outlining methods to be used in the beginning of shortage when dams stop overflowing. This plan to be 11149 given in steps and presented to council at next meeting for their consideration and input to be brought back to first meeting in April.

Discussion of Portable Sign Enforcement Provisions that were placed on a Temporary hold.

Council briefly discussed this matter with the City Manager. Councilman Daniels said he would like the City Manager to inquire of Mr. C.W. Cline as to his 11150 intent to appeal the case. Council also discussed the five areas in sign ordinance which are in contention and are advertised for public hearing at the Planning Commission Meeting to be held March 15th. No action was taken.

Consideration of Proposed Contract, and Addendum #1, with Dewberry and Davis Concerning Proposal for Engineering Services.

Council discussed this matter at length.

On motion by W.F. McElroy, seconded by Cliff Daniels and carried by unanimous roll call vote, Council moved to enter into Water Contract with Dewberry & Davis with the recommendation of the Attorney in making corrections and the fee up to 11151 \$15,000 to be taken from Capital Account #9150.

Approval of an Annual Bingo Permit for the Norton Rescue Squad, Inc. and Setting of the Permit Fee and Audit Fee.

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous vote, Council moved that upon request of the City Manager for one year bingo permit be approved with no application fee and no audit fee but subject to the stipulations that persons responsible for money will be covered by Fidelity Bond. 11152

Consideration of Nominations to an Ad-Hoc Clinch Water Supply Advisory Committee working with the State Water Control Board.

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous 11153 vote, Council moved that Charlie Brown be nominated to Ad-Hoc Clinch Water Supply Advisory Committee or his substitute.

Discussion of a Proposed Change to the Sidewalk Repair and Replacement Policy of the City.

Council discussed this matter at length, after which council agreed for the City Attorney to prepare a draft of policy for repair to sidewalks and the City 11154 Manager bring back to next council meeting.

Discussion of a proposed change to the Scheduled May 1, 1984 meeting of City Council. Council agreed for this meeting to be held on May 2, 1984 at 7:30 P.M. 11155

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous vote, Council moved to go into executive session to discuss legal matters as Per 2.1-344 (A) (6) of the Code of Virginia, as Amended. 11156

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous vote, Council moved they go back into regular session.

Mayor Hunnicutt declared council back in regular session.

Mayor Hunnicutt advised he was sorry to report that have no conclusion on 11157 legal matter to report.

Comments by City Manager - Mr. Brown advised of difficulty they had been having with traffic signals - pushing wrong button when wanted to cross street. Supposed to push button under signal and not on back of post. Council discussed these signals 11158 with City Manager.

There being no further business to come before the council same adjourned.
