

The regular meeting of the City Council was held in the Municipal Court Room on December 7, 1982 at 7:30 P.M. with Mayor Hunnicutt presiding.

Present: George Hunnicutt, W.F. McElroy, Cliff Daniels, Vic Jones, Roy Roberts

Also Present: C.R. Brown, City Manager & Kenneth Asbury, Attorney

On motion by W.F. McElroy, seconded by Roy Roberts and carried by unanimous vote, Council moved that the minutes of Nov. 16, 1982 be approved as presented. 10706

On motion by Cliff Daniels, seconded by W.F. McElroy and carried by unanimous vote, Council moved to amend the agenda to insert after item 3, an executive session to consider personnel and pending litigation. 10707

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous vote, Council moved they go back into regular session. 10708

The Mayor announced that with respect to personnel, Council would handle that when it comes up on the agenda. No action taken on pending litigation. 10709

Mayor Hunnicutt ask if anyone had anything to bring before the council other than what was on the agenda. 10710

The Mayor announced it was time for public hearing on an Ordinance to Amend and Reordain the Business License Ordinance of the City of Norton, said Amendment to include Fees for persons holding mixed Beverage Licenses. 10711

The City Attorney read this proposed ordinance. No comments from the public.

On motion by Roy Roberts, seconded by W.F. McElroy and carried by unanimous roll call vote, Council moved the adoption of the following Ordinance on first reading: "An Ordinance of the City Council of the City of Norton, Virginia adopting and Imposing a Local License Tax Upon Persons Holding Mixed Beverage and Caterers' Licenses for Establishments within the City of Norton." Appointment of prosecuting attorney for the City of Norton -

On motion by Cliff Daniels, seconded by Roy Roberts and carried by unanimous roll call vote, Council moved that the City Attorney be authorized and directed to hire a prosecuting attorney, to be confirmed at the next council meeting at the basic amount of money in the budget to serve as prosecuting attorney for the City of Norton. 10713

Request for two equivalent sewer connections by the Wise County Christian School. Mr. Ed Phillips, Board Member of the Christian School spoke to council on this matter stressing the need for this. Council briefly discussed this matter. 10714

On motion by Cliff Daniels, seconded by Vic Jones and carried by the following votes, Council moved that request be granted of two equivalent sewer connections for the Wise County Christian School: McElroy, Hunnicutt, Jones, Daniels, YES; Roberts, NO.

Request for 58 (Fifty-eight) equivalent sewer connections by Wise County Plaza. Larry Carty, representing Mullins Consulting Engineers, was present, addressing the request for 58 equivalent sewer connections for Wise County Plaza. Mr. Allison also spoke on the matter. Council discussed this matter at length.

On motion by Vic Jones, seconded by W.F. McElroy and carried by the following roll call votes: McElroy, Hunnicutt, Jones, Daniels, YES; Roberts, NO, Council moved that Wise County Plaza be granted 58 equivalent sewer connections to be used between this date and May 6, 1983, and if not used, hooked-up and paid for will expire necessitating having to come back for any renewal and that usage plan as presented to the Planning Commission will be strictly adhered to. 10715

Council addressed the matter of having fulfilled their obligations to this shopping Plaza. Individual councilmen expressed their opinion on the matter.

The City Manager advised that the gas tanks had been delivered, installed and were filled at the new facility. He also advised he thought they would be moving into the facilities at an early date.

Councilman Jones spoke briefly with regard to replacing pipe line on Kentucky Avenue and also touched on subject of Clear Creek Water Project.


The City Manager briefly discussed with council the leaks which were found with help of TVA Assistance.


The City Manager announced the second hearing would be held on Dec. 21, 1982 on proposed new ordinance as presented this date.
