

The regular meeting of the City Council was held in the Municipal Court Room on January 20, 1981 at 7:30 P.M. with Mayor Hunnicutt presiding.

Also Present: G. M. Newman, City Manager & Kenneth Asbury, Attorney

On motion by Cliff Daniels, seconded by Robert Collier and carried by unanimous vote, Council moved that minutes of January 6th, January 14th and January 16th be approved as presented.

On motion by Cliff Daniels, seconded by Robert Collier and carried by following votes: McElroy, Collier, Daniels, Jones Yes - Hunnicutt No. Council moved that when both sides indicate that they are ready to hear Item #9 that same be moved up on the agenda.

Mr. Ed Phillips of Thompson & Litton firm presented Proposals for the incorporation of Clear Creek Water Shed. Mr. Phillips presented six alternatives, giving cost estimates and amount of water anticipated. Council discussed this matter at length with Mr. Phillips.

On motion by Robert Collier, seconded by Cliff Daniels and carried by unanimous roll call vote, council moved that the City Attorney prepare an ordinance asking the Circuit Court to call special election for purpose of enabling authority to borrow sum of up to \$1,500,000.00 to be borrowed from F.H.A. or issue Revenue Bonds for Water System Improvements.

Mayor Hunnicutt stated the next thing to be taken up was personal privilege license for the Dance Factory. He ask that it be noted that he abdicated this seat on grounds that he could not become involved because of Conflict of Interest in this issue. He turned meeting over to Vice Mayor McElroy.

Miles Bolling Appeared before council requesting renewal of The Sportsman Pool Room license.

On motion by Vic Jones, seconded by Cliff Daniels and carried by unanimous roll call vote, council moved that pool room license for Frank Bolling, T/A The Sportsman be renewed.

Vice Mayor McElroy stated it was time for request by Robert Bolling for personal privilege license renewal for Dance Factory.

Robert Bolling was not present at Council meeting to present his application.

Joe Wolfe, representing citizens from that area of The Dance Factory appeared before council with a petition objecting to renewal of this license. Citizens for and against the renewal stood and a few of them spoke on the matter. The vice mayor stated council did not have anything to move on and would go on to the next thing on the agenda. Council advised citizens present that if the matter gets on agenda they will be notified.

Ed Tate, representing St. Mary's Hospital appeared before council presenting request for street lights and also advised they had prepared right of way deeds for the City. Council advised Mr. Tate that Deeds had to be presented to City Planning Commission before coming before the City Council. Council discussed the matter of street lights at length with Mr. Tate. Council advised Mr. Tate that there would be no problem regarding lights but that at present time a review was being made of the entire city lighting system.

On motion by Robert Collier, seconded by Vic Jones and carried by unanimous vote, Council moved that the following resolution of the City Council of City of Norton "Supporting Work of Southwest Virginia Emergency Medical Service Council, Inc." was passed. (Insert)

Ordinance regulating solicitation was carried over until next council meeting.

10034


Mr. Newman advised council he would like to have a proposed use Revenue Sharing Public Hearing on February 5th at 3:30 P.M.
